- Thorough operational knowledge and skills of operating a commercial motor vehicle and related equipment to be operated.
- Ability to operate equipment safely and efficiently.
- Must keep time and material records.
- Knowledge of different types and sizes of aggregates.
- Must have maneuvering and backing skills.
- Must be able to communicate effectively on the radio system.
- Must maintain driver's daily logs.
- Connect and disconnect trailers.
- Be aware of other equipment and personnel working in the area.
- Possess ability to follow instructions with strong oral and written skills.
- Display a professional and courteous attitude to co-workers and supervisors.
- Report to assigned job area in proper attire and ready to begin work at the designated start time.
- Strict adherence to safety requirements and procedures as outlined in policies and procedures manual, and MSHA and/or OSHA guidelines.
- Ability to think clearly no matter the stress or difficulty of your circumstances.
- Possess a strong work ethic and commitment to excellence.
- Ability to comprehend and communicate specific directions to ensure the safety of all.

- Flexibility to work various schedules and stay late when necessary with little or no notice.
